Honorable Joy Reynolds McCoy

The Honorable Joy Reynolds McCoy is a Judge of the Court of Common Pleas in Lycoming County, Pennsylvania. She oversees the Family Court Division. Judge McCoy primarily presides over cases involving custody, support, divorce, domestic violence, delinquency and Children & Youth matters. She has been the Administrative Judge for Children & Youth since January, 2010, when she began her first term as Judge. Judge McCoy maintains a leadership role in the Children's Roundtable Initiative as Chair of the Hearing Officers Workgroup, as well as serving on the Drug & Alcohol Workgroup, Benchbook Committee, and Benchbook Edit Committee. In 2011, Judge McCoy received Lycoming County YWCA's Unsung Hero Award and Women of Excellence Award.

Honorable Christylee L. Peck

Judge Peck was elected to the Cumberland County Court of Common Pleas in 2011; her term expires in 2022. She presides over dependency, family, criminal, civil and orphan's court matters. Prior to serving on the bench, she served as a Senior Assistant District Attorney for Cumberland County, prosecuting violent criminal offenders who committed homicides, rapes, robberies, and crimes against children. She previously worked in the child abuse unit for the Lancaster County District Attorney's office and as an associate at the law firm of Rhoads and Sinon, LLP in Harrisburg. Judge Peck previously served on the Board for the Dickinson School of Law. She has served on the Advisory Board of Pinnacle Health Children's Resource Center in Harrisburg. She currently serves as co-chair of the Legal Representation Workgroup of the Pennsylvania Statewide Children's Roundtable and is a current member of the Board for Pennsylvania Court Appointed Special Advocates for Children. She also is a recent addition to the Pennsylvania Supreme Court's Commission on Judicial Independence.
