

Philadelphia Family Court Family Finding Report to the Court Questions to Ask during Dependency Proceedings



Children/Parents

- Has anyone talked with you about all of us working together to make sure you have people in your life that care about and love you now and in the future?
- 2. Who do you love? Who do you enjoy spending time with? Who do you want to see/talk to or spend more time with?
- 3. If you had a problem or wanted to share some good news, who are the first 3 people you would reach out to?
- 4. Who do you spend time with or connect with regularly on social media?

Child Welfare Professionals

- 1. Tell me about the child/ family's network?
- 2. Since the last court hearing, what have you done to identify and involve family and kin?
- 3. Is the network active in the child's life? How?
- 4. Have you reviewed the child's most recent connections circle? Are there any newly identified people you plan to talk to?
- 5. What are your next Family Finding steps?

Shelter Care hearings (In Person hearings)

Attorneys

- 1. Have you had the opportunity to review the FF Report to the Court with your client?
- 2. Has your client identified anyone else who the agency can talk to about possibly being a part of his/ her network?
- 3. Has your client been actively involved in the family finding process?
