PA Supreme Court to Co-Sponsor Family Group Decision-Making Conference Court's Initiative Is Improving Lives of Dependent Children

As part of a statewide initiative to improve the lives of dependent children, the Supreme Court of Pennsylvania is co-sponsoring a two-day Family Group Decision-Making Conference for judges, county commissioners, attorneys and child welfare professionals.

Pennsylvania Supreme Court Justice Max Baer said, "The state's family group decision-making process is designed to engage the wider family group, including relatives, friends, community members, and others, in collectively making decisions to provide lifelong support for abused and neglected children."

Your coverage of the conference, held on April 12 and 13 at the Hershey Lodge and Convention Center; 325 University Drive; Hershey, PA, is invited. (The conference schedule is enclosed.)

Keynote speakers include Justice Baer; Dr. Felicia Haywood, Director of Student Affairs, Penn State Harrisburg, and a nationally certified and professionally licensed counselor; and George P. Hartwick III, Dauphin County Commissioner. Other conference participants include Pennsylvania Department of Public Welfare Secretary Gary Alexander, PA Juvenile Court Judges' Commission Executive Director James Anderson; Deputy Secretary, Office of Children, Youth and Families Beverly Mackereth; and Administrative Office of Pennsylvania Court Office of Children and Families in the Courts Administrator Sandy Moore.

Since 2006 the Office of Children and Families in the Courts, along with the Department of Public Welfare and other partners, have safely reduced the number of dependent and delinquent children in temporary foster care homes by more than 7,000, or 33 percent. Placing these children into a permanent family setting greatly improves their chances to succeed and significantly reduces the cost of institutional care, saving Pennsylvania an estimated \$117 million annually.

"With enhanced judicial oversight and strength-based, family-led practices, our overriding goals are to keep children safely in their homes, return others to their homes, and when staying or returning home is not possible, find quickly the best alternative permanent home for every child," Justice Baer said.
